This full-time attorney position provides telephone advice, counsel, and brief services to clients on a range of civil legal issues. This is primarily a remote position with occasional in-person requirements for meetings, events, and other work-related activities.

#### **Essential Functions**

- Conducts telephone interviews, assesses cases for merit or defenses, provides advice and/or brief services in the areas of family law, housing law, and consumer protection.
- Refers cases internally to LSNV staff or externally to the staff of Legal Aid Works (LAW).
- Follows office directives by participating in task force meetings, practice group meetings, and case review sessions conducted by the Managing Attorney.
- Maintains files in a professional manner, in accordance with the Case Management Guidelines.
- Participates in LSNV and external trainings and meetings, as requested.
- Provides internal and external training, as requested.
- Performs other duties as assigned.

## Qualifications

- Must be licensed with the Virginia State Bar, or have two years of practice in another state (LAC Rule 1A:9).
- Commitment to social justice, racial justice, and/or public interest work, strongly preferred.
- Experience in community engagement and advocacy, strongly preferred.
- Excellent verbal and written communication and interpersonal skills.
- Strong litigation experience, preferred.
- Legal aid experience, strongly preferred.
- Fluency in Spanish (verbal and written), preferred.
